**IN THE MATTER OF APPROVING AND AUTHORIZING
THE USE OF COUNTY ROADS FOR THE ST. CLAIR
ELKS ANNUAL SIDE BY SIDE POKER RUN**

WHEREAS, the Franklin County Commission received an inquiry requesting authorization of the use of county roads for the St. Clair Elks Annual Side by Side Poker Run taking place on September 28, 2024, wherein participants will be operating UTV's (Utility Terrain Vehicles") along the route shown attached hereto; and

WHEREAS, funds raised from the St. Clair Elks Annual Side by Side Poker Run will support the Franklin County D.A.R.E. (Drug Abuse Resistance Education) program; and

WHEREAS, Section 304.013.1(5) RSMo. permits governing bodies to authorize licensed drivers for special use of all-terrain vehicles on county roads within said county; and

WHEREAS, in an effort to ensure the safety of all drivers, Franklin County requires proper signage to be present alerting motor vehicles of the presence of UTV's traveling along the route of the St. Clair Elks Annual Side by Side Poker Run.

IT IS THEREFORE ORDERED by the Franklin County Commission that licensed drivers are authorized to operate UTV's along the route of the St. Clair Elks Annual Side by Side Poker Run on September 28, 2024.

At Virginia Mines Church take a left onto Rye Creek Rd.

At stops sign make a right onto Hwy. 47 (need 2 people for traffic)

At 30 cross onto River Bend (NEED PEOPLE FOR TRAFFIC)

Right on Barton

Left on Bethel Church Rd.

Left onto Mill Hill Rd. Right onto Old Cove to Old Cove Canoe Rental. On the Right (2nd stop)

Leaving Old Cove Canoe Rental turn right onto Old Cove Rd. At Moselle cross tracks onto Hwy. AH.

Turn right on Shawneetown Ford Rd. keep left at Shawneetown Spur

Turn right onto S. Outer Rd. Cross over the overpass, than turn Right on North Outer Rd.

Right onto Indian Prairie Rd. than right onto Prairie Del Rd.

Right on Progress PKW. Than right into Veterans Memorial Park (3rd Stop)

Leaving V.M. Park turn right onto Progress PKW. THEN RIGHT ONTO Denmark Rd.

Left onto N. Outer Rd., then Right onto the over pass, than right onto S. Outer Rd.

Left onto AH to Moselle. Cross the tracks then Right onto Moselle Rd. To Hwy. TT

Turn right onto Hwy. TT

Left onto Brush Creek Rd. Right onto Mill Hill , left onto Frisco than right on Main

Left onto North St. And back To the Elks on the right .
